PRELIMINARY NOTIFICATION

Where as it appears to the District Collector, Vizianagaram that the lands specified in the schedule below are needed for a public purpose, to wit, for 17L Sub Minor taking off @ Km.5.700 of 7L Minor of Vizianagaram Branch Canal (from Km.0.340 to Km.1.100) under Thotapalli Barrage Project, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of Section-11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act,2013 (Central Act No.30 of 2013).

The Environment Impact Assessment clearance issued vide Lr.No.J/12011/10/2002A/Dt.29.08.2005 of the Ministry of Environment and Forest, Govt. of India. There are no displaced families due to this Land Acquisition.

Now, therefore, in exercise of the powers conferred under-section 12 of the Act, the District Collector, Vizianagaram hereby, designates the Special Dy. Collector (LA), TBP Unit-I, Parvathipuram, his staff and workmen to exercise the powers conferred under the above said section.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of the land i.e., sale / purchase etc., or create any encumbrances on such land from the date of this notification without the prior approval of the Collector / Land Acquisition Officer.

Objections to the acquisition, if any, may be filed by the person(s) interested within 60 (sixty) days from the date of publication of this Notification as provided under section 15 of the Act before the Collector / Land Acquisition Officer.
