**PRELIMINARY NOTIFICATION**

Whereas it appears to the District Collector, Vizianagaram that the lands specified in the schedule below are needed for a public purpose, to wit, for Gajapathinagaram Branch Canal ( from Km 34.075 to Km 35.825) under Thotapalli Barrage Project, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of Section -11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act No.30 of 2013).

Environmental Impact Assessment (EIA) was taken up by the I&CAD Department, Government of Andhra Pradesh in the year 2005 and Environment clearance granted by MOEF vide letter No.J-12011/10/2002 A /dt.29.8.2005. There are no displaced families due to this Land Acquisition.

Now, therefore, in exercise of the powers conferred under Section-12 of the Act, the District Collector, Vizianagaram hereby, designates the Special Deputy Collector, T.B.P.Unit-III, Parvathipuram, his staff and workmen to exercise the powers conferred under the above said section.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale / purchase etc. or create any encumbrances on such land from the date of this notification without the prior approval of the Collector/ Land Acquisition Officer.

Objections to the acquisitions, if any, may be filed by the person(s) interested within 60 (sixty) days from the date of publication of this Notification as provided under Section -15 of the Act before the Collector/ Land Acquisition Officer.
